Minutes from the April 1, 2001 CVIDS Meeting

In Attendance: Jean Hecht, Jackie Westhoff, Verne Moore, Mary Moore, Lynn Stoll, Reva Allen, Kay Hill, Jim Glasson, Sylvia Seymour, Kim Edge.

We discussed where and when to have our spring sale. Kim volunteered to call Davenport to see about participating in the plant sale on May 20th at Vandevere Park. She will also call the Cedar Rapids Parks Department about renting a shelter from them for a plant sale. Jean will investigate the availability of our usual spot at Morrison Park in Coralville. We would prefer to get Vandevere Park on May 20th. If that is not possible, Coralville on May 19th is another possibility. We will finalize the date according to which places are available and when. Please bring any photos you have of your donated plants or catalog photos to help the customers visualize the plants. Ken Capps has some left over plants from the last sale lined out at his house. If they don't sell this year we will get rid of them. All plants need to be clean and have new labels. Jim volunteered to make a large plywood sign to place near the roadside at the sale.

We also discussed whether we would have a table at Project Green this year. Lynn agreed to staff it and Jean and Kim will get 100 flyers printed up about our club activities and sales.

We then discussed who gets to participate in the lottery system we use to distribute auction plants. These people grow the plants on for two years and get to keep the original number of fans, but return the increases to the club. The first decision was to make Fred and Margaret McDowell lifetime members. We then decided to define active individual members as those who have paid their dues for that year and done <u>any two</u> of the following: have attended at least 2 meetings per year; have assisted in club functions (spring or fall sale, summer tours, etc.); have donated plants to a sale; have bid in the silent auction. This passed unanimously. It was also decided that active members can get plants to grow on in the second year of their memberships (after they have paid dues twice).

We discussed whether we should eliminate the family membership. We decided not to as the new definition of an active member eliminates the problem since only "active" spouses/partners would get plants.

We discussed "lost" plants—those that are not returned to us after two years. It was decided to write them off as losses to the club.

We then discussed when to meet to distribute the plants that are coming this spring. We will meet on Sunday, April 29th at Lynn Stoll's at 2 p.m. The lottery will be held there. We discussed whether members should be required to be in attendance to participate in the drawing. It was decided that if a member cannot attend, they are responsible for getting a list of their plant preferences to someone who will be there to be their advocate and choose for them from the available plants. If a member cannot attend and does not get their plant list to someone at the meeting, they will not be included in the drawing. In order to be eligible, you must be an active member and have paid your dues, which are due by the date of the drawing, April 29th. If you are eligible but cannot attend you can mail your list of preferences to Lynn Stoll, 999 310th St., Atalissa, IA, 52720, in order to participate.

We then discussed new business. Lynn proposed as a club activity that we make and maintain a public daylily bed in honor of Fred McDowell. There was support for the idea but concern about volunteer maintenance of the bed. Jean has experienced a lot of trouble in getting volunteers coordinated to maintain North Liberty's beds. Lynn suggested that Project Green might be a resource to help us find a location and to take on the maintenance. It was also suggested that we could hire a landscaping company ourselves to maintain the bed. Lynn had to leave at this point so this idea will be discussed further at a future meeting.

We discussed some club specifics. The legal minimum for a quorum in a non-profit organization in 10% of the members. The Region One bylaws and our non-profit status was questioned. We decided not to pursue this further.

Jim Glasson announced he will not be able to regularly attend club meetings and therefore he is resigning as club secretary. Kim Edge volunteered to the acting secretary until there is a vote on new officers in the fall. Members, please consider volunteering to serve as an officer in the next elections! Terms are for two years. We will need to fill the offices of President, Vice-President, Treasurer and Secretary/Newsletter Editor.

Sylvia brought up the subject of a fall banquet. Some possible speakers were discussed. There was interest in Curt Hanson. Jackie will contact him and ask him about his possible availability in the fall.

Jean brought up the subject of our having a club garden tour. Some possible destinations were discussed. The fall banquet and the garden tour issues will be discussed further at the next meeting, Sunday, April 29th at 2 p.m. at Stoll's in Atalissa.






