CVIDS Summer Tour Update

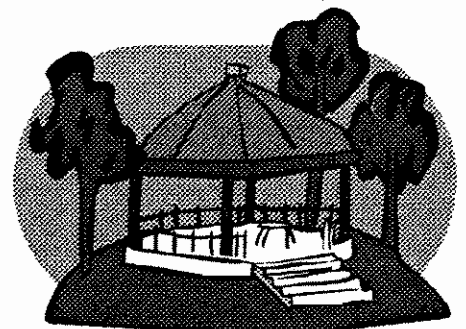

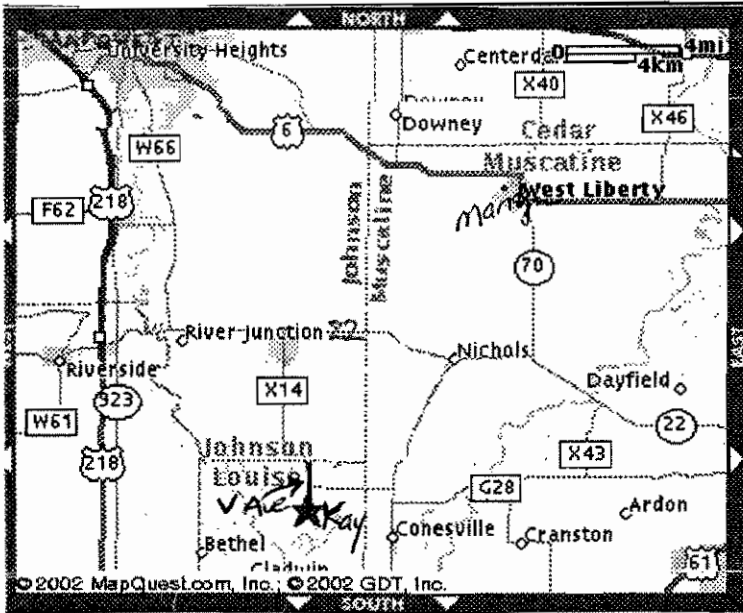
The weather was quite nice and there seemed to be more customers in the park this year than last.



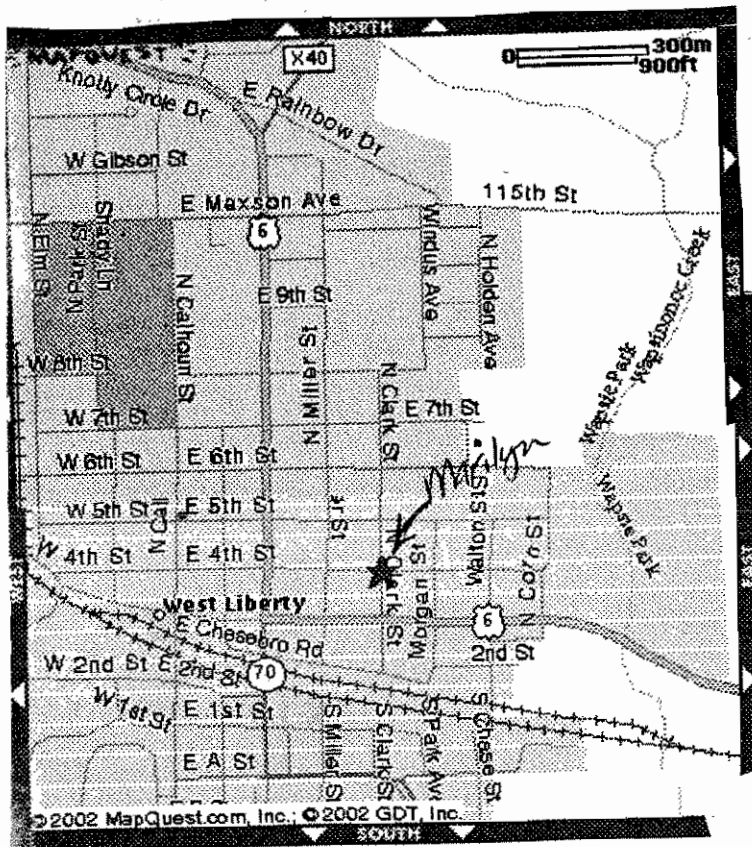
Directions to the July 13th, 2002 CVIDS Summer Tour Gardens:

• Kay's & Marilyn's (West Liberty):



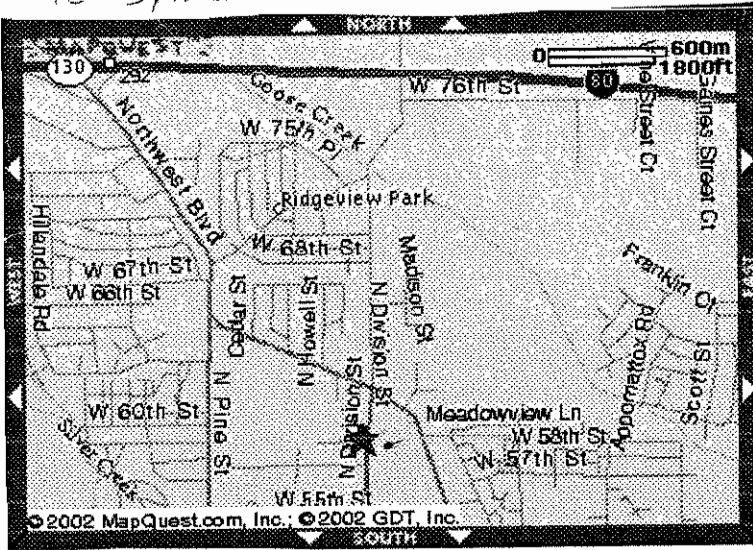
To get to Kay Hill's, take the Highway 22 exit off of Highway 218 (what Interstate 380 is called south of I-80). Take Highway 22 east to the intersection with County Road X14. Take that south until it intersects with a gravel road called V Avenue (you go straight). Go along V Avenue for 1 mile. Kay's mailbox has her name on it. Their address is 23085 V Avenue, Conesville, IA, phone # (319)725-4387.



West Liberty (close-up):

To get to Marilyn Little's: From Kay's, go back to G28 (paved road) turn right, got to the junction with Highway 70 and turn left. Proceed to Nichols where you will intersect with Highway 22 and turn right. Proceed to a T intersection and follow Highway 70 (left turn) to West Liberty. Follow this road to town and a 4-way stop. Go one more block, turn right on Fourth Street. Proceed two blocks to the corner of Clark and 4th. Turn left and park on Clark. The house is gray and white with a corner door, 501 East Fourth St., West Liberty, IA, phone # (319)627-2910.

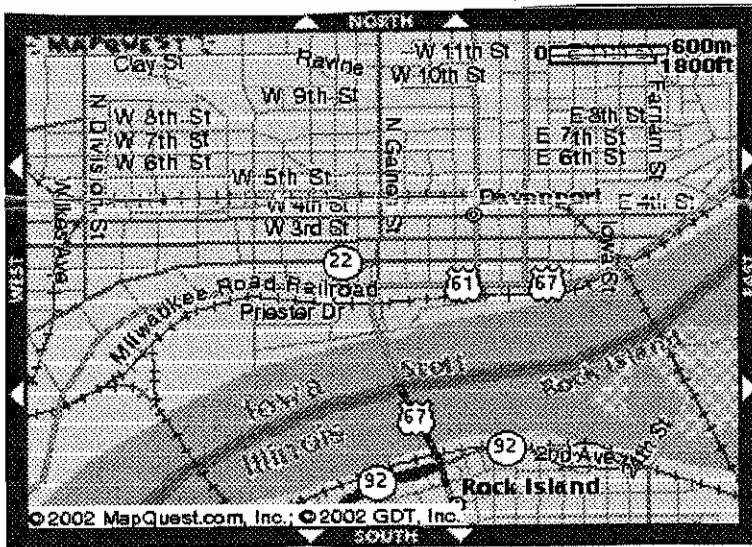
To Sylvia's:



To get to Sylvia Seymour's: After touring Marilyn's, to get back to I-80 go back to Columbus, turn right (north) and go to Garfield Ave. You will see Alpen Ford on the left, turn right and take Garfield to I-80 (5 miles). Turn right on I-80 and go approximately 40 miles to Davenport. Take the Northwest Blvd./ Highway 130 exit. Turn right (south); follow Northwest Blvd (it curves around) to Division St (the third stoplight). Take a right turn onto Division street and go about 2 blocks. Make a right turn onto 59th St. Sylvia's is the third house, a gray ranch house with daylilies. There is extra parking at the school on Division St. Sylvia's address is 1722 W. 59th St., Davenport, IA, phone # (319) 386-9767.

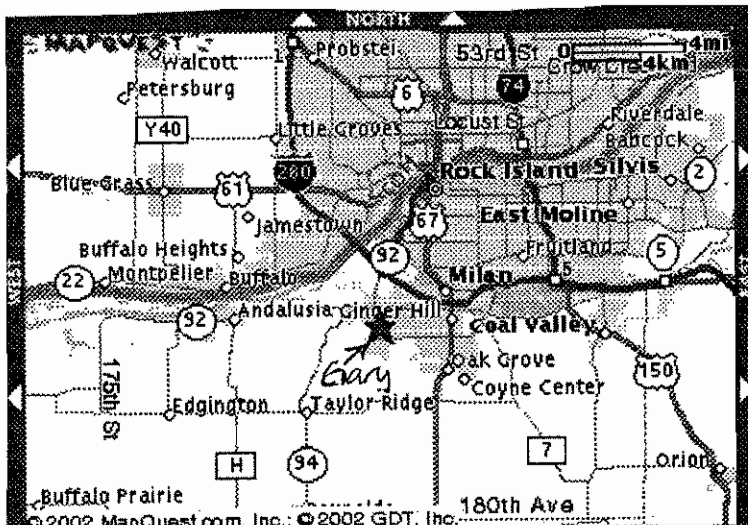

Downtown to the Centennial Bridge:



To get to Gary Williams': From Sylvia's house, take Division St. south to W. 3rd St. and take a left onto it. Take W. 3rd St. east to N. Gaines St. Take a right onto N. Gaines St, which is the street for the Centennial Bridge. The toll of 50 cents to cross. Go over the Mississippi on the Centennial Bridge (Highway 67). Take a right onto Highway 92. Take Highway 92 to the 2nd stop light; the first stoplight was Andalusia, the 2nd is at 35th St. West. A sign will say Highland Springs Golf Course. Take a right at this intersection. In 50 feet, take another right (past the mailboxes). Go around the lake a quarter mile. Gary's house will be the second house you see. His address is 9206 35th St. West, Milan, IL, phone # (309) 756-0606.
