An excellent opportunity to attend a nearby regional AHS event, tour some excellent gardens, and meet some new daylily friends. You don't have to be an AHS member to attend.

Aug. 8-9: American Iris Society, Region 21 fall meeting, Omaha, NE. Details and registration form in this newsletter. An opportunity to learn about evaluating iris from an outstanding hybridizer, meet some new friends, and get some *great* bargains at the iris sale and auction. You don't have to be an AIS member to attend.

Aug. 22: CVIDS Annual Plant Sale, 11 AM - 3 PM, Riverside Gardens, Monticello. This is our only fund-raising event. We hope all our members will be able to contribute plants, help with digging and labeling, and/or help out at the sale itself. Please label all plants with name, color, and price, at a minimum. Choice items might also include year of introduction and list price. Please bring plants to Riverside Gardens at 9:00; all plants should be priced before the sale. If you have plants to contribute but can't bring them to the sale yourself, please call the Stolls (946-3471) to arrange for someone to pick them up.

Directions to Stolls: From I-80 Exit 265 (Atalissa), go south 1/4 mile, then turn right (west) on 310th St. Go 1.0 mile on 310th St., then turn right at Johnson (into lane marked "Private Property"). Extra parking in field in front of house.

Directions to McDowells: Interstate 80 to Exit 246 (Highway 1-Iowa City-Solon-Lake McBride). Follow Highway 1 into Iowa City. Go about 3 miles on Highway 1 (it is Dodge St. in Iowa City) to the fourth traffic light, at East Burlington St. Turn left on to Burlington St., go three blocks to Summit St. (a traffic light at this intersection), go one block to East Court St. (a dead end on Summit St.), turn left onto East Court St. Go a block and a half to #1118, a large white frame house on the left as you go East.

Directions to Hobbs's: From Iowa City, take Hwy. 218 South to Donelson; then turn east on Rt. 2. About 10 miles from Donelson, you will start down a long hill where you can see Ft. Madison in the distance. The Hobbs garden is on the left close to the top of the hill. (If you reach the Ridgewood Lounge on the left, you've just passed it!)

CVIDS Now Covered by AHS LIABILITY INSURANCE

The American Hemerocallis Society has recently negotiated a liability insurance policy to cover all national and regional activities, as well as all local affiliates. To take advantage of this insurance policy, CVIDS has become an AHS affiliate by sending in a check to cover membership dues in the national organization. This means that if someone were to be injured at one of our activities (e.g., slipping in a kitchen, falling in a garden), even if it were not an official AHS activity, we would have liability coverage if needed. This coverage is effective immediately.

The 1992 A.I.S. Region 21 Fall Meeting & Auction will be held August 8 & 9. The Quality Inn Crown Court at Highway 370 at Hillcrest in Bellevue, Nebraska will be head-quarters for the activities. 


