**February 14, 2015 Meeting** will be held at the Johnson County Extension Office, Iowa City, Iowa located at 3109 Old Hiway 218 South. (It may also be called Oakcrest Hill Road South East on some Google maps.) Potluck to start at <u>11:00</u> with meeting at 12:00 noon. *PLEASE NOTE THE CHANGE OF TIME*. Another meeting follows in the hall, so we need to vacate the building before 4 pm. We will have two featured talks, highlighting our own members.

<u>Sherry McCarville</u> will share her personal experience with essential oils. She will discuss the pros and cons, how and where to research for information about essential oils. She will show us how to use a still, demonstrate the use of several different types of diffusers. She will provide us with lots of reference materials and personal experience. She has created a handout with some recipes and websites of different companies. Sherry McCarville, <u>Karmin Mullins</u> and their friend Bev, will lead us in the direction of learning more about using our own plant materials for our health benefits.

<u>Barb Papenhausen</u> will hold an informational demonstration about soil amendments and the use of chemicals that may enhance our growing of daylilies and hostas. Barb states that her garden has such poor soil-clay that she must dig it out and amend it. She will demonstrate a new product that several elite hybridizers use- Karol Emmerich and Nan Ripley to be a name dropper. This soil medium allows the roots to grow and expand. She will also do a show and tell about different chemicals that she has worked with to find the magic elixir. Names like Super Thrive, Bap-10. She says nothing has died, but it did not grow hair on Bob's head either. Be prepared for a fun afternoon.

**March 21, 2015 Meeting** will be held in Davenport at New Hope Presbyterian Church, 4209 West Locust Street. Zora Ronan will show the slides about the 2015 Club Plant picks. I always look forward to seeing the wide variety that we will be able to choose from. Many members qualified to earn a plant this year. Barb McCreight will present on "The Pre-Emergent that saved my Garden". Directions will be available in the March newsletter, at the February meeting, and on the website.

The following amendment to CVIDS Constitutional Bylaw was Approved January 17, 2015 by members attending the January 17th, 2015 meeting. A big thank you to Jonathan Poulton for helping us to achieve a way to elect officers. Since this article passed in January, I am looking for 3 volunteers to serve for the Nominating Committee for 2015. Elections will be held in November for Vice President and Treasurer.

#### **ARTICLE IV - ELECTION OF OFFICERS**

Section 1. To promote continuity of information, the election of the President and Secretary will take place in even years, whereas the Vice President and Treasurer will be elected in odd years. Section 2. In January, the President will call for 2-3 volunteers to serve as an ad hoc Nominating Committee. Committee members will decide which of them serves as Chair. The Committee is charged with establishing by the end of the October meeting a slate of candidates for the open offices that year. These openings will be publicized mid-year at Society events and via the Newsletter and website. Section 3. Although the Nominating Committee Chair will usually approach potential candidates regarding open positions, any Society member wishing to run is strongly encouraged to contact the Nominating Committee Chair directly.

Section 4. After allowing additions to be made from the floor during the October meeting, the Committee Chair will publish the electoral slate of candidates in the Fall Newsletter, via e-mail, and on the website.

Section 5. The election will take place at the November business meeting, if necessary by secret ballot when there are multiple candidates for a given office. Any members wishing to vote in the election but unable to attend that meeting may cast their votes by contacting the President beforehand. After taking into consideration any absentee ballots, the President will announce the election results.

Section 6. The newly elected officers will take office at the conclusion of the November business meeting.

Section 7. The Board will fill any vacancies that occur mid-term.

#### Minutes for CVIDS Meeting: January 17, 2015 at Coralville Public Library

The first meeting of the 2015 year began at 12 noon with a potluck and fellowship. Fifty-two members attended. Zora Ronan presented a program on Garden Etiquette, the AHS Medal Winners and information about the judging process. Dave Appelquist presented slides featuring the ice cream social of the 2014 Garden Tour at his White Oak Garden. He also highlighted daylilies from his hybridizing efforts.

President Nancy Carlisle called the business meeting to order at 2:02 PM. Sign-up sheets for committee assignments circulated during the meeting. Sign-up sheets also included a list for ordering the AHS Illustrated Guide to Daylilies at a group rate of \$13 and plant stakes. Volunteers were requested for club booths at the Winter Gardening Fairs at Kirkwood and Muscatine. It was suggested that our booths provide information on growing daylilies and highlight the diversity in daylily cultivars by including the club plant photo notebook.

Several members eulogized Charter Member Lynn Stoll. Lynn's leadership and passion were instrumental in the formation of CVIDS. Her contributions in both the iris and daylily world were noted. She became a role model and mentor as she demonstrated high standards for both herself and her plants. Her influence will be evident for years to come.

Because of parking limitations at the May Plant Sale in North Liberty, a new location will be needed. Dave and Sue Kramer have participated in the Indian Creek Nature Center Plant Sale and offered their help if the club

would want to apply for the space they will vacate this year. Gary Oster made a motion to reserve space at the Indian Creek Nature Center Plant Sale (deadline is mid-February) and continue discussion. Motion seconded by Sherri Baldonado. Motion failed.

Colleen Hansen made a motion to gather information on the possibility of having the spring sale at the Muscatine Environmental Learning Center OR the possibility of participating in not more than two small-town city-wide garage sales. Colleen volunteered to research these possibilities and give the information to the President before our next meeting. Jonathan Poulton seconded, motion carried.

Treasurer Sherri Baldonado presented the final fiscal report for 2014 and assisted President Nancy in presenting the 2015 proposed budget. Motion made by Dave Appelquist, seconded by Clay Dawson to approve the budget. Motion carried.

Jonathan Poulton presented the proposed By-law Amendment to Article IV-Election of Officers. The change further explains the mechanism for officer election. This amendment has been published and presented twice. Motion by Jonathan Poulton, seconded by Keith Riewerts to approve the amendment to Article IV. Motion carried.

The next meeting will be February 14<sup>th</sup> at the Johnson County Extension Office in Iowa City. **NOTE: the potluck start time will be moved up to 11:00 A.M**. CVIDS will have their 25<sup>th</sup> anniversary in March. Bring ideas for an Anniversary Celebration to the February meeting.

Keith Riewerts announced that Karol Emmerich of Minneapolis will be our speaker for the November 14, 2015 banquet. The location will probably be the Holiday Inn in Iowa City with possibly an earlier start time.

Several lucky members were winners in the door prize drawing.

## **Calendar and Culture**

Here are a few things that have worked for me in Southeast Iowa.

**Early April;** or earlier if the garden is dry. Clear the leaves, debris, and over wintering weeds from the clumps. I left the old leaves on the clumps the preceding Fall for mulch and to collect snow for additional mulch and moisture, but the dead foilage is no longer useful and eliminates harbors for thrips, snails, and spring sickness and makes future processing easier. After clearing, apply a pre-emergence herbicide such as Preen, Surflan, or Prowl. I use a liquid herbicide called Prowl (4 oz/gal) applied with a tank sprayer. It has a yellow dye in it for use as a marker to determine coverage. Use gloves and avoid getting it on your clothing or shoes as the stain is hard to remove. You may have to get it at a grain elevator or farm supply, but it does a better job than Preen and is cheaper in the long run. It has a long shelf life. Don't use it on vegetable gardens. This sure eliminates a lot of hoeing and weed pulling. I think this product is not as destructive to soil microbial activity as roto-tilling. I still see a lot of earthworms.

Late April; Spread Milorganite which is a deer deterrent and provides some micronutrients like iron, calcium, zinc, sulphur, and copper. It is a slow release and won't burn. If you hybridize and haven't started seeds indoors, put stored seeds into a cross marked plastic bag with some damp sand, vermiculite or sphagnum moss about a week before you want to plant in the garden. When you see the small root (radicle) start from the bottom of the seed, plant it in the garden about 1/4-1/2" deep. I plant thickly, then transplant in early August to about 8" apart which gives them room to develop. A few will bloom the next year, but it usually takes 2 years. "I sow because I can't sew. That way I get better "hems" than sewing. So, I'm looking for new 'patterns'".

**Early May;** Good time to transplant. If soil is dry, <u>now</u> is the time to water. This is when the plants are setting up for scapes and buds in July. If transplanting, put in a few alfalfa pellets or aged horse manure. "She was just the jockey's daughter, but all the horsemen knew 'er."

**Late May;** Test the soil for pH, NPK and if desired, top dress with a <u>slow</u> release lawn fertilizer. I use Sta Green 20-0-5 from Lowe's. It will feed all Summer with one application and won't burn, A lot cheaper than Osmocote. Using a balanced fertilizer such as 12-12-12 can accumulate too much Phosphorus in the soil.

Spray with Bobbex deer deterrent. It has been tested by the University of Tennessee to be better than Liquid Fence and others. The only thing better is an actual fence. It seems to be a systemic for a lasting effect and rain resistant. You may have to reapply occasionally on newer growth. Apply with a tank sprayer on scapes and buds. A homemade deer repellent mix is: 1 tablespoon ground red pepper, 1 tablespoon granulated garlic, 1 tablespoon Louisiana hot sauce mixed with 2 tablespoons of Gain fabric softener, mix with a little hot water, pour into a tank sprayer, fill to a level of one gallon with water. Don't drink it! It tastes awful.

**Late May-June;** Spray for those pesky broad leaf weeds with Ortho Weed B Gone Max. It is a lawn herbicide that kills broad leaf weeds and crab grass but doesn't affect daylilies or iris because they are narrow leaf (monocots not dicots). You can spray right into the clump. I buy the concentrate & mix it in a tank sprayer. It will also kill crabgrass. To kill young grass you can use Ortho Grass B Gone.

**Late June- August;** Enjoy & visit gardens! Buy new ""must have" daylilies! Make crosses for new & better? seedlings. Evaluate seedlings for plant and flower quality. Line out possible introductions.

September; Collect seeds in envelopes and mark the crosses.

**November;** Mulch new acquisitions and evergreens with pine needles or straw. It reduces soil temperature and prevents drying out by wind, and collects snow for moisture.

Dec.-March; Rest and attend meetings.

## Arlene Oster's Famous Cream Puff Recipe, courtesy of Gary Oster

Cream Puffs 1 cup water ½ cup butter or margarine 1 cup all-purpose flour 4 large eggs

Vanilla Fluff Filling 1 large package (8-serving size) vanilla instant pudding and pie filling mix

½ cup milk
teaspoon Vanilla extract
cup Cool whip
Powdered sugar

Directions

- 1. Heat oven to 400°F. In 2 1/2-quart saucepan, heat water and butter to rolling boil. Stir in flour; reduce heat to low. Stir vigorously over low heat about 1 minute or until mixture forms a ball; remove from heat. Beat in eggs, all at once; continue beating until smooth. *Gary said his mom used an electric mixer as she grew older. She also used the microwave to do this step.*
- 2. On ungreased cookie sheet, drop dough by slightly less than 1/4 cupfuls about 3 inches apart. Bake 35 to 40 minutes or until puffed and golden. Cool away from draft, about 30 minutes. *Gary called it a quick oven, started it at 450 for 10 minutes and then turned it down to 400. and NO PEEKING!*
- 3. Make the filling. (directions are below). Cut off top third of each puff and pull out any strands of soft dough. Fill puffs with filling; replace tops. Cover; refrigerate until serving. Store covered in refrigerator.
- Vanilla Fluff Filling: In large bowl, beat pudding mix, milk, vanilla extract, with electric mixer on low speed until well blended. Add cool whip; beat on high speed 1 to 2 minutes or until soft peaks form. Fill puffs. Serve immediately, or cover and refrigerate up to 3 hours. Just before serving, sprinkle with powdered sugar.

A little puff pointer: Make sure the cooked dough is still warm when you drop it onto the cookie sheet. Not to worry, it's supposed to be a little sticky and paste-like.

Omit the filling and frosting, and fill with ice cream, sherbet, sorbet, berries or whipped cream. Dust with powdered sugar, or drizzle with purchased chocolate sauce.

Gary said they always cut the puffs in half and filled both sides with pudding mix before reassembling. Gary says the vanilla extract and filling both halves over full, is what makes this recipe from Arlene so good. He prefers to use two boxes of pudding mix and 3 cups of milk. He mentioned that they were always served in their Lowden restaurant on the days they served ham balls. His mother Arlene used to make over 110 in a day. I know that Gary still loves to make this recipe. Whenever he brings these, I grab one and eat it before anything else.

**ELIGIBILITY REQUIREMENTS:** To be eligible to receive a club plant for the current year, a member must have:

► contributed to the club's activities during the previous calendar year (January 1 through December 31) by undertaking any two of the following:

- (1) attended two club meetings (includes garden tour but not the banquet)

- (4) donated plants to a club sale
- (5) assisted at the CVIDS plant sales or auctions
- (6) presented a club program
- (7) hosted a CVIDS garden tour
- (8) written an article for the newsletter
- (9) bid in the Silent Auction of returning club plants
- (10) performed any other activity that contributes to the success of the club.

ELIGIBILITY REQUIREMENTS: To be eligible to receive a club plant for the current year, a member must have:

contributed to the club's activities during the previous calendar year (January 1 through December 31) by undertaking any four two of the following:

(1) Attend two club meetings <del>(includes garden tour but not the banquet)</del> (excludes plant distribution, garden tours and banquet)

- (2) Serve as a CVIDS Board member
- (3) Chair or co-chaired a committee
- (4) Donate plants to a club sale
- (5) Assist at the CVIDS plant sales or auctions
- (6) Present a club program
- (7) Host a CVIDS garden tour
- (8) Write an article or provide photos for the website or newsletter
- (9) Bid in the Silent Auction of returning club plants
- (10) Win a live auction
- (11) Perform any activity that contributes to the success of the club.

#### **SELECTION BY PROXY:**

If a member with eligibility to receive a plant is unable to attend the Plant Distribution, he/she may assign a proxy to select a plant for them during the drawing. However, the member must inform the Treasurer of their designated proxy prior to the Plant Distribution. If no proxy is designated, no proxy will be chosen for them him or her.

This proposed handbook change will be discussed at the February meeting, at which time we shall vote on any amendments. I plan on a vote on the final document at the March 2015 meeting.
