1:00 p.m.           Presentation by Sam McCord on "Bio Markers." Materials engineer Sam McCord gave an informative and very interesting presentation on the ins and outs and "all abouts" of creating his highly technical business of Bio Markers. He detailed the business and science of "compounding" bio-materials along with resins to develop and produce injection-molded products ranging from the Plant Markers, which are currently available, to bio-resin pallets, which, all told, save weight, space and money for the end user. He and his wife, Mary, work together in their business.

1:30 p.m.           Presentation by Sarah Hankemeier on decorating Rose Bowl Floats. Sarah's delightful presentation detailed a trip by her and her husband, Tom, to Pasadena, California, just prior to the 2016 Rose Bowl Parade, where they spent two days as hands-on participants in learning about and participating in the actual decorating of the Lutheran Church Rose Bowl Parade float. We all learned just how demanding and precise the requirements for every element of each float is, from placing beans exactly the same, in each row, for even minor details on each float. Then, she participated in the exacting process of cutting and placing the roses, trimmed precisely to the same length, into water-filled vases, in preparation for installation on the final float. She even ended up with blisters on her fingers while cutting rose stems during this process. And amazingly, her husband conceded to having a great time with this adventure. He and Sarah are even considering a repeat "bucket list" episode. Now, if only Iowa football can have a repeat performance too!

2:15 p.m.           Zora Ronan was introduced and the PowerPoint presentation of the 2017 Club Plants was shown.
