Officer Reports

- Treasurer Jackie Westhoff The 2023 club accounts were audited by Peggy Rash-Daniels and she will be doing the 2024 audit. The club checking account balance as of November 8th is \$24,340.42. Expenses include paying webmaster Jonathan Poulton \$382.10 to renew the club website's domain hosting (a 2 year renewal that saves money vs. an annual renewal) and \$299.97 for the purchase of a 3-year SSL security certificate for the club website. Regarding the amount paid for domain hosting, there is a slight discrepancy in the amount listed in the September board meeting minutes for the domain fee \$45.98 as compared to \$46.34 on the invoice, and Jackie has clarified that the amount paid is \$382.10. Checks outstanding include the invoice from Radisson for the banquet today. There will be an update of the checking account total at the end of December for the board to review.
- Secretary Cari Rusnak: Meeting minutes for October written by Nancy Rash were sent to the club via email on November 8 - one update to the minutes is adding that there was an audit to the treasurer's report. A motion to approve the October meeting minutes was made by Nancy Carlisle and seconded by Eli Hanson. Motion passed.
